Information Collection

We collect personal and health information from our patients when they seek healthcare services at A Family Healing Center. This information may include, but is not limited to, names, contact details, medical history, current health conditions, medications, and insurance information.

We may collect information through in-person visits, phone calls, electronic forms, patient portals, and other communication channels.

Use of Information

Disclosure of Information

Patient information will not be disclosed to third parties without explicit consent, except in situations where required by law, court order, or in cases of public health emergencies.

We may share patient information with other healthcare providers involved in the patient's care for the purpose of care coordination and continuity.

Data Security

We maintain appropriate physical, electronic, and administrative safeguards to protect patient information against unauthorized access, disclosure, alteration, or destruction.

Access to patient information is restricted to authorized personnel who require the information to perform their job responsibilities.

Patient Rights

Patients have the right to access their own personal and health information, request corrections, and obtain a copy of their records, as permitted by law.

Patients have the right to request restrictions on the use and disclosure of their information, as well as to revoke their consent for specific uses.
